As a result, winners who receive a cash prize or an annuity payment after January 1, 2016 must report those payments as taxable income on a PA Schedule T when filing a Pennsylvania Personal. Before you see a dollar of lottery winnings, the IRS will take 25%. Up to an additional 13% could be withheld in state and local taxes, depending on where you live. Still, you'll probably owe more when taxes are due, since the top federal tax rate is 37%. You must **withhold federal income tax** from the **winnings** if the **winnings** minus the wager exceed \$5,000 and the **winnings** are at least 300 times the wager. Withhold 24% of the proceeds (the **winnings** minus the wager). This is regular gambling **withholding**. Seriously, the best time to start on **2016 taxes** is now The U.S. government automatically withholds 25 percent of such large prizes if the **winner** is a citizen or resident with a Social Security. Your state will **tax** the **winnings** too, unless you live in a state that does not impose a state-level income **tax**. The **tax** rate will be determined by your income. So, for instance, if you make \$42,000 annually and file as single, your **federal tax** rate is 22%. If you win \$1,000, your total income is \$43,000, and your **tax** rate is still 22%. In **2016**, American **lottery** hopefuls spent approximately \$80 billion dollars on a chance at changing their lives forever. However, few winners are ever prepared for what comes next. If you're like many **lottery** winners, you might be wondering about the **lottery tax** rate and how much **tax** you'll pay on your **winnings**. The simplest answer is, it depends. The **winner** will have to pay the difference between 25 **percent** and the top tax bracket of roughly 40 **percent** the next April 15. The total **federal tax** bill would come to about \$368.3 million, leaving.
